Important Information Regarding Investment Manager Trading Practices

This document provides information regarding the trading practices of investment managers ("Managers") who participate in certain investment advisory programs sponsored by Wells Fargo Advisors. Wells Fargo Advisors sponsors multiple Separately Managed Account Programs ("Programs") that utilize the services of Managers who may execute trades away from Wells Fargo Advisors and, as a result, can incur additional trading costs that are paid for by Wells Fargo Advisors Program Clients ("you", "your"). Any such trading costs are separate and distinct from Program Fees. You should understand the trading methods of the Managers available through the Programs, as well as the factors that influence such trading decisions.

Managers participating in the following Programs may choose to trade away from Wells Fargo Advisors: Personalized UMA and Private Advisor Network ("PAN"). Best Execution Obligation

Each Manager has an obligation to obtain "best execution" of your transactions. In meeting this obligation, the Manager must seek to execute securities transactions for you in such a manner that your total cost or proceeds in each transaction is the most favorable under the circumstances. In assessing whether this standard is met, the Manager should consider the full range and quality of a broker's services when selecting an executing broker, including, among other things, execution capability, commission rate, financial responsibility, responsiveness to the adviser, and the value of any research services provided. The evaluation of these factors may result in the Manager electing to execute your trade(s) away from Wells Fargo Advisors. Wells Fargo Advisors' Best Execution Committee reviews trading activity and the vendors and systems we use to process transactions, among other things.

Trade Away/Step Out Definition

Under the Programs, we are generally appointed as sole and exclusive broker by you with respect to your advisory program account for the execution of transactions. Our Program Fee covers transaction costs when transactions are executed through us. Managers unaffiliated with Wells Fargo Advisors participating in our Personalized UMA and PAN Programs may elect to execute transactions with other firms as they deem appropriate, taking into account a number of factors such as best execution responsibilities, research services and other qualitative factors. Certain Managers may elect to execute all, or a majority of their transactions with other firms based on these factors.

When transactions are executed with other firms, including transactions executed through our affiliates, there are trading costs in executing the transaction that may be borne by you. Any additional execution costs on trades done away from us are in addition to our Program Fee and may increase your overall cost. Managers are required to consider these additional costs when reviewing their best execution responsibilities in determining whether to trade through us or another firm, however, as stated, there are other factors that may also impact their decision in where to place a trade.

In general, fixed income transactions incur additional costs such as a markup/markdown or spread that are included in the net price and are not reflected as a separate charge on trade confirmations or account statements. As a result, Managers that trade fixed income securities away from us are generally unable to provide this information.

The information on the following table was provided by Managers within our Personalized UMA and PAN programs. We asked Managers to provide us with strategy level ranges around trading and additional costs for transactions not performed through Wells Fargo Advisors. This information represents activity for 2023. Past trading practices are not necessarily representative of a Manager's current or future practices; Managers may choose to trade away from WFA more or less frequently than provided in the chart below; and Managers that reported no trades done away from WFA during the time period presented may choose to do so in the future. As a result, future fees and expenses related to a Manager's trade away activity may be greater in future periods. Wells Fargo Advisors reasonably believes the information provided by the Managers is correct, but it should be noted, we have not audited or validated these figures. BPS represents basis points (0.01%) trading cost per amount of trade in question; CPS represents trading cost in Cents Per Share (\$0.01) on any shares traded.
